#### Exterior Property Changes

As spring turns into summer, the weather becomes perfect for updates to your house and property. Just remember, that ALL exterior changes to a property need to be approved by the Architectural Review Committee. "This includes but is not limited to an outbuilding, addition, unattached garage, shed, barn, driveway, deck, exterior paint color, brick or stone work, fireplace, fence, wall, swing set, alternative energy source, pool, trailer, storage container, portable toilet, dumpster" (Rules & Regulations, sec. 5, par. 1). You can submit online by going to the "Architectural Review" tab on www.tablersestates.org or you can mail it to the P.O. box above or deliver it in person to any ARC member. It can take up to 30 days to process a request, so get them in soon. Failure to get a change approved may result in a fine. Please review the rest of the rules and regulations for the neighborhood that were mailed out with the last newsletter and can also be found online under the "covenants and by laws" tab. We thank you in advance for continuing to make this development one of the most desirable in Berkeley County.

- 2. Keep exterior surface structures free of dirt, fungus, and stains. (Article IX, par. 4 & 22)

### **Excess Deer Population**

Multiple Tabler Estates homeowners inquired about the possibility of allowing deer hunting to eliminate the excess deer population in our community. Many cities and towns in West Virginia are experiencing problems with deer vehicle collisions, increased danger of contracting Lyme disease, and damage to ornamental shrubs and gardens due to increasing deer populations. Recognizing that the only practical and economical way to reduce deer herds within urban areas and housing developments is by hunting, the West Virginia Division of Natural Resources enacted regulations allowing incorporated cities, towns, villages and homeowners associations the opportunity to have a more liberal deer archery/crossbow season. This special deer season in no way supersedes local regulations or community prohibitions on hunting. Urban season starts in the beginning of September and runs through the end of December and is limited to pre-approved hunters that must use bow/crossbow and are required to hunt from an elevated position for safety reasons.

The 2019 registration season has passed but there will be community discussions to educate the Tabler Estates homeowners on the specific details related to this special opportunity. Each lot will have an opportunity to voice their opinion on whether their lot will allow the hunts to occur on their property, or not.

The deadline for the HOA representatives to apply for the 2020 season is March 1<sup>st</sup>, 2020 for the upcoming season and it will need to be approved by the HOA.
