Letter from the President

Congratulations to Ward Reynolds who was reelected to the Board at the November annual meeting. Thank you to all those who attended. This year's annual meeting will again be held the first Saturday in November.

We didn't accomplish everything we set out to in 2017 but we did make progress. We had our first every block party in May. We had not one but two community yard sales. Tree trimming continued along the roadway in both the spring and fall. A one-way loop was put in place during Halloween; additional signs and replacements signs were posted; 3 additional lights were approved and installation was started. I can't wait to see what we accomplish in 2018.

Some of the discussion points at the annual meeting included the concern about fireworks during the 4th of July, the deer overpopulation in the neighborhood, the need to have "no soliciting" signs at the beginning of the neighborhood to deter non-residents and their guests from entering, and the desire to reduce drivers' speed in the neighborhood. Covenants Reminder

"ARTICLE VII, UTILITY AND DRAINAGE EASEMENT RESERVATION, The Declarant reserves unto the Declarant and/or unto Tabler Estates Homeowners Association, Inc., their successors, and/or assigns, the right to erect, install and maintain telephone electric and cable T.V. systems, conduits, equipment, and sewer, gas, water lines, storm water management and drainage ditches, and similar utility structures, or to grant easements or rights-of-way therefore, with the right of ingress and egress for the purpose of erection, installation or maintenance on, over, or under a strip of land twenty (20) feet wide at any point along the front lines of each Lot within The Properties and a strip of land ten (10) feet wide at any point along the side and rear lines of each Lot within the Properties. This easement shall be in excess of any street or road right-of-way and the ten (10) feet wide strip shall be measured from the edge of any road right-of-way line.
