Updated Regulation Material

While our neighborhood continues to look beautiful, it seems as though some homeowners have been overlooking a few policies in the covenants. The board feels that this may be because the covenant document is cumbersome and not something that people take the time to read; it can be confusing and unclear. For the past year, the board has been working to make the covenants clearer. To do this, we have created/updated a few documents to spell out the rules, procedures, and enforcement of the covenants. The intention of these documents is not to add rules but to clarify the covenant that already exists and add enforcement procedures to streamline the process. We have included the "Rules and Regulations" sheet and the "Compliance Enforcement Policy" for your reading pleasure. Please read over these documents at your earliest convenience so you can understand and follow the policies set forth. The third document is specific to the Architectural Review Committee and can be found online at our website if you plan to make any changes to the exterior of your property. We hope these documents help.

Rules & Regulation's Maintenance Highlight

1. No shingles, siding, railings, steps, windows, doors, shutters, and other exterior surfaces should be missing or broken. (Article IX, paragraph 4 & 22)
2. Keep exterior surface structures free of dirt, fungus, and stains. (Article IX, par. 4 & 22)

SLOW DOWN!

Speed continues to be a concern throughout the neighborhood. It is brought up at every safety meeting and has been a topic of discussion on Facebook several times. This will be the number one topic at this month's safety meeting on Feb. 27th, 6:30pm at Greg Sanchez's house, 496 Fantasia Rd. Some ideas that can be discussed are speed cameras, speed bumps, and radar signs. The bottom line is that we need to make this neighborhood safe for kids, pedestrians, and other drivers. Currently people do not feel safe so we need to step up as a community and slow down. If you have an idea or an opinion that can help resolve the situation, come to the safety meeting.

Exterior Improvements

Spring is coming soon enough, or maybe not quite soon enough. I know this means that outside projects will be starting up again. Please remember that any exterior changes to your property need to be approved by the ARC. This includes but is not limited to: an outbuilding, addition, unattached garage, shed, barn, driveway, deck, exterior paint color, brick or stone work, fireplace, fence, wall, swing set, alternative energy source, pool, trailer, storage container, portable toilet, dumpster. Rules & Regulations Highlights

No structures (including buildings, fences, pools, etc.) may be built or plants be planted within the easement or right of way. Easements are 10 feet from the side or rear of the property and 20 feet from the road. (Article IX, par. 15 & 22, Article VII par. 1)
